- The Union has been in a state of flux and changes are going to be made
- There is a \$10 million proposal going to the Board of Trustees in regards to a repurposing of the Fish Bowl lounge
 - It will be refurnished and reconstructed to be a collaborative space for all students
 - o Focus skills-based workshops and programming for students
- Student Events (i.e. TedEx and Hack-a-thon)
 - o Programming focuses on teaching practical skills in a dynamic environment
 - Learning
 - Connecting
 - Creating
- · Repurposing existing space to create a places of high-tech workshop spaces

Carolina Creates team:

- Taking measures to decrease volume such as partitions and signs that redirect students and let them know where to go for study purposes
- Setting up meetings in the space when they least coincide with peak study hours
- The space would not involve cramming people into limited space; there would be limits

Carolina Union Director

Orystal will be taking Carly and Gabe to High Point manufacturing factory with the intention of refreshing some of the furniture in the building; a process that occurs every decade or so. They are going to the manufacturing plant and they will test and select the furniture directly from the manufacturing company. The Union wanted to involve students in this process and the plant is excited to receive students input as well.

 - o Will see a lot of new faces; several temps who are helping with the transition
 - Looking to fill in these positions during this semester and through the summer
- o "The Gift" project
 - o Second phase of this project in the Plaza
 - o This was approved years ago, before Crystal began the job
 - o There will be an unveiling ceremony
 - Disappointed that they weren't able to meet the original deadline, but the project will be finished soon
 - Space and location issues were considered

Subcommittee Reports

- o Space Allocation
 - o Final Appeals
 - Relay for Life
 - Darrin Benjumea, Relay for Life Vice Director
 - Will Yokeley, Relay for Life
 - A special thanks to the Space Allocation Committee for their consideration and time
 - Relay for Life is the signature fundraising organization for the American Cancer Society
 - Celebrating 19th year on UNC's campus
 - o Raise money that is donated to the ACS for patient services, research, advocacy, education etc.
 - In the past, they have raised approximately \$170,000 annually (this is their goal this year as well)
 - o Event on Friday (3/28)
 - Currently have D3103 in the bottom of the Union
 - While filling out the application, there was an emphasis on space allocation for storage or for business conducting
 - Under the assumption that they could do both, but they understand that there are many other student organizations that need space as well
 - Appealing for an office space rather than a storage space in order to allow the charity to thrive
 - Need the space for regular office hours (print-out with the application)
 - 18 executive positions, sub-chairs who are expected to hold at least 1 hour of office hours weekly



- Used for questions, donations, information, etc.
- Way for teams and team leaders to drop off money to the accounting chair
- A safe place for the accountant to count the money (prevents theft and money loss)

GlobeMed UNC

- Danny Rahal, Co-Leader of GlobeMed committees, next year's Co-President
- Kaitlin Quallen, current Co-President
- National office at Northwestern; 50 national chapters
- Each chapter is partnered with a grassroots non-profit organization
- UNC's partner is "Raising a Village in Uganda"
- Throughout the year, GlobeMed's purpose is to raise funding and then to send a member to Uganda to collaborate with the organization's non-profit partner
- During the semester, GlobeMed spreads word about their partner
- Allocated the storage space for 1303C
- Need the office space for professional Skype calls
 - o Few spaces on campus that achieve this
 - o Too much noise in many areas
 - Need to make calls to the National Office, and as the Co-Presidents, GlobeMed needs to maintain good relations
 - o GlobeMed's MOU says that they need to remain in contact with their partner
 - o Availability
 - Kenan-Bill grant, need to maintain in contact with Duke
 - Office hours
 - Office hours for the co-presidents
 - Need a private space to communicate with mentors
 - Group work, collaboration with committees within the organization
- Also a need for storage, but office space is the priority
 - o Need the office to maintain the organization's chapter

o Board Approval

- Telling already-established organizations that have been granted space to leave to make room for other groups
- Connor talked to Scott Hudson about the space allocation



- Scott proposed clearing the whole back wall of 3103 and filling it with desks (5-10)
- Relay for Life has overspill of materials on the whole back wall of 1303 (where the bowling alley used to be); they already have one of the largest storage spaces that the Union offers
- Adding a K and L to 1303
- It says a lot to these organizations to put in work to get the space
- Too many desks would be a fire code concern
- Need to be fair to all organizations involved
- Main question: Does the Union want to add 2 more desks to 1303?
- Moving Lambda Pi Chi and Sigma Pi to K and L, GlobeMed is currently in D
- Carly moved to approve space allocation for two extra desks for next year
 - · Connor seconded motion
 - Motion approved

New Business

Student Congress Bill

- Passed on the consent calendar a new bill on the 25th
- Bylaws change without student voting
- Addition of Article 3
 - If Christy Lambden signs the bill, it will have to be approved by the Union and Congress
 - President does not have to sign to consent
 - Need 2/3 majority from both Caroline Union Board of Directors and Student Congress

Amendment Proposal

- Summary of changes
 - Want to reduce the number members but still have a fair representation of the student body
 - The current bylaw document implies 27 members
 - o \$10,000 cap on Director spending has been increased to \$50,000
 - Aims to increase communication flow between Board of Directors and CUAB
 - Facilitates an eventual splitting of the current Union Presidency responsibilities between the Board of Directors and CUAB
 - o Minutes are to be made public and accessible on the website
 - Includes a list of quarterly, semester, and annual reports to be made to the Board of Directors
 - Designated student members changes
 - Student Body President should ideally represent all students
