## Approval of the April 24, 2019 Minutes

## **Executive Director Updates**

A tentative offer has been made to one of the candidates for the Executive Director position of the Carolina Union. Should the candidate accept the offer, the search committee will receive the news of the candidate first, then the Board of Directors, then the Carolina Union staff, and finally the campus will be notified.

#### Graduate and Professional Students Action Plan

The Board is continuing efforts to extend the Union's reach to Graduate and Professional students and organizations. Lee Roberts, in the Office of Student Life and Leadership, has compiled lists of related Graduate and Professional groups on campus with the intent to create focus groups to better understand their needs and how the Union can serve them.

## **Union Polling Station**

Chairman Jaylen proposed to the Board, on behalf of NCPIRG's request, for the Union to erect polling stations for the election in March. The Board expressed interest in doing so, but elected to revisit the matter at a later date after gathering more logistical information from NCPIRG.

## **Building Renovation Updates**

The construction of the Union Auditorium is complete and now available for use.

## **Sustainability Initiative Brainstorming**

Chairman Jaylen relayed to the Board that Brad Ives, the Associate Vice Chancellor for Campus Enterprises and Chief Sustainability Officer at UNC, is no longer with the university. Brad oversaw the 3 Zeroes

Initiative, and the Board expressed interest in continuing the sustainability practices associated with the initiative and implementing more sustainable practices in the Union's daily functions.
